**DATES and
SCHEDULE:**

RAIN:

In the case of inclement weather if it is determined that the tournament cannot be run outside **at all**, the tournament will be moved to site TBD and posted on www.wcd3.org . If the weather is intermittent and the tournament **can** be started outside then it will remain outside until it is completed.

TIMES:

All coaches will meet at the Auburn High School on the first day of competition at 8:00am for a coaches meeting. Players will meet at 8:10am. Matches will begin at 8:30am.

The order of matches will be girls singles, boys singles, girls doubles, boys doubles. The first round will be single elimination.

**APPEALS
COMMITTEE:**

An appeals committee will be selected at the coaches meeting on the first day of competition. Two coaches from each league and the tournament director will make up the committee.

ADMISSION:

No charge for admission.

RULES OF PLAY:

1. All participants in a specific match must report to the site official before his/her/their match for court assignment and balls. At the conclusion of the match winners (and losers in a non-elimination round) must report back to the desk.
2. Rules of Tennis and Cases and Decisions and The Code, both sanctioned by the U.S.T.A. will govern play.
3. The W.I.A.A. supersedes the USTA rulebook on coaching in that it allows a two-minute break between the first and second set for the coach to speak with his/her player(s). Do not leave the court. Only the coach or coach designee may talk to the player(s). If there is a third set, then a ten-minute break is allowed. Players may leave the court at that time.
4. Ten-minute warm-up, serves included.
5. New balls will be issued in the third set for winner's bracket semifinals and the championship matches.
6. Make all calls on your side of the net only. Make them quickly, loudly, honestly, and accompany them with a hand signal.
7. The point penalty system will be in effect. The first infraction will result in the loss of a point. The second infraction will result in loss of a game. The third will result in a default of the offender. A default will result in the application of W.I.A.A. handbook rule 18:24.2. The defaulted player will be ineligible for his/her next contest.
8. Appropriate tennis attire is expected of all participants as approved by the W.I.A.A. and individual schools.

BALLS: Each School is required to provide two cans of tournament hard court balls per tournament entry. If your school qualifies a boy's singles and a girl's doubles team you would provide 4 cans of tennis balls.
